- Direct manpower with valid E01 certification
- Direct manpower with minimum 5 years' experience in undertaking OPUG (Optical Fibre Underground) cable laying or similar and associated installation works.
- Minimum 5 years' proven track record in OPUG or similar cable laying and installation.
- Company-owned machinery, equipment and tools with valid test/inspection certificates, as applicable.
- NEBOSH qualified HSE employee or access to suitably qualified HSE third party support.
- Subcontracting of the main scope, i.e., cable installation, is not allowed. Interested parties may only subcontract part of the work scope which is considered as minor works such as fibre optic splicing and testing and must declare the scope to be subcontracted and the name of the subcontractor to be engaged.

- 2. Proof of track record for undertaking OPUG cable installation projects for years 2017 to 2022 stating clients' name, project name, contract value and status
- 3. CVs of company's direct employees and key personnel with minimum 5 years' experience in OPUG cable installation where at least 1 direct employee has valid E01 certification (state their names, years of experience, training and certification as applicable)
- 4. CV of in-house NEBOSH qualified HSE employee or written confirmation of access to suitably qualified HSE third party NEBOSH support services.
- 5. List of company-owned cable installation and trenching equipment, such as: cable pulling winch with torque meter, cable drum stand, excavators, Hiab crane truck, etc., with valid inspection certificates.
- 6. Certificate of business registration and particular of directors, owners and shareholders.
- 7. Copy of latest 'Form of Annual Return of a Company having Share Capital'.
- 8. Official letter from local Bank issued in 2022 stating name and designation of all authorised bank signatories for the company and copies of their latest ICs or passports.
