Section 1: INSTRUCTION TO BIDDERS

1. Bid Scope

- 1.1. Berakas Power Company Sdn Bhd ('BPC') invites sealed bids from Bidders to quote for the purchase of Assorted Scrap Cables from BPC. These Instructions to Bidders shall be read together with the Conditions of Sale.
- 1.2. The Bid Documents comprise the following:

SECTION 1	Instruction to Bidders
SECTION 2	Conditions of Sale
SECTION 3	Form of Bid
SECTION 4	Bill of Quantities
- 1.3. Bidders must carefully examine the contents of the Bid Documents. Failure to comply with the bid submission requirements will be at the Bidder's own risk. If any pages or content are missing, duplicated, or unclear, the Bidder must inform BPC promptly to arrange for amendment/correction.
- 1.4. While the Bid Documents are, to the best of BPC's knowledge, complete and accurate, Bidders remain solely responsible for conducting their own investigations and verifying all information relevant to their Bid. BPC shall not be held liable for any omissions or inaccuracies.
- 1.5. Bids will be considered only if submitted in accordance with the instructions provided herein and in the prescribed form(s) outlined in this Instruction to Bidders.

2. Bid Submission Deadline

- 2.1. The Bid Submission Deadline is **before 12:00 hours (Brunei Time) on Thursday, 21 August 2025**. The Bidder bears sole responsibility for ensuring that the full Bid Submissions is received by BPC prior to the Bid Submission Deadline.
- 2.2. BPC may, at its sole discretion, extend the Bid Submission Deadline by issuing an addendum. Upon such extension, all obligations and rights relating to the original deadline shall apply to the extended deadline.

3. Request for Clarification or Extension

- 3.1. Any request for clarification or extension must be submitted in writing to the designated representative below no later than three (3) working days before the Bid Submission Deadline. Requests received after this time will not be entertained.

- 3.2. If a Bidder contact any person within BPC regarding the Bid, other than the designated representative, BPC reserves the right, at its sole discretion, to disregard the Bidder's submission.
- 3.3. Response to clarifications will be emailed to all bidders who must acknowledge receipt.

4. Bid Submission

- 4.1. The Bid Submission shall comprise the following, duly completed, signed and stamped with the Bidder's official company stamp on every page:
 - a. **Section 3: Form of Bid** (*indicating the total purchase price for the scrap cables*);
 - b. **Section 4: Bill of Quantities** (*stating the purchase value in accordance with the quantities provided by BPC*);
- 4.2. **Submission by email**
 - All documents listed in Clause 4.1 shall be submitted via email to tenders@bpc-brunei.com, and must be received before the Bid Submission Deadline.
 - The **maximum email size** (including attachments) **is 18MB**.
 - Submissions must not be copied (cc) to any other BPC email address.
 - Submissions sent as download links, compressed (.zip/.rar) files, or password-protected files will be deemed non-compliant and rejected.

5. Rejection of Bid Submission

BPC reserves the absolute right to reject any bid submission that:

- is received after the Bid Submission Deadline;
- contains unauthorised alteration to the Bid Document;
- is submitted on non-BPC issued Bid Document; or
- fails to comply with these Instructions to Bidders.

6. Bid Validity

- 6.1. Bids shall remain valid for **three (3) months** from the Bid Submission Deadline.
- 6.2. BPC may request an extension of the validity period.
- 6.3. Bidders agreeing to such extension request shall not be permitted to modify their Bid.

7. Cost of Bidding

All costs and expenses incurred in preparing, submitting, and clarifying a Bid, including travel and incidental costs, shall be borne entirely by the Bidder. BPC shall not, under any circumstances, be liable for such costs.

8. Bid Currency

Prices shall be quoted in the currency stated in the **Form of Bid** and **Bill of Quantities**. No adjustment will be made for currency fluctuations, and all associated risks shall be borne by the Bidder.

9. Withdrawal of Bid

No submitted bids may be withdrawn after the Bid Submission Deadline. Any withdrawal thereafter may result in the Bidder being suspended from future bidding opportunities with BPC.

10. Acceptance or Non-Acceptance of Bid

- 10.1. BPC is not obliged to accept the highest bid, any bid, or to provide reasons for non-acceptance.
- 10.2. The issuance of a Letter of Award constitutes a binding agreement obliging the successful Bidder to purchase the Assorted Scrap Cables at the awarded price, in accordance with the Conditions of Sale, and the Bill of Quantities.
- 10.3. Any attempt to offer a bribe or inducement to influence the bid process will result in immediate disqualification of the Bidder.

11. Confidentiality

- 11.1. All information contained in the Bid Documents is strictly confidential and may only be disclosed to relevant persons directly involved in the preparation of the Bid, subject to:
 - a. prior written notice to BPC identifying such persons;
 - b. execution of a written confidentiality undertaking
- 11.2. Should any Bidder be found to have released any information on the Bid Document or on this Bid in any form, to any other third party without prior written consent from BPC, the Bid Submission from such Bidder shall be rejected and the Bidder shall be suspended from participating in future bids.

12. Conflict of Interest

- 12.1. All bidders are required to identify any conflicts or potential conflicts of interest.
- 12.2. If the Bidder has a personal or professional connection with BPC or has undertaken work for companies or any organization which may present a conflict of interest, non-disclosure of such association may result in the disqualification of the Bidder. An example is past or current working relationship, affiliation or association with any other bidders or potential bidders.
- 12.3. In the event of any such conflict or potential conflict BPC shall, at its absolute discretion, decide on the appropriate course of action and the decision of BPC will be final and binding in this regard.

Section 2: CONDITIONS OF SALE

1. GENERAL

- 1.1 These Conditions of Sale govern the sale of items by Berakas Power Company Sdn Bhd (BPC). By submitting a bid, the Bidder confirms full and unconditional acceptance of these Conditions.
- 1.2 The sale of each item will be made to the **highest evaluated bid**, as determined solely by BPC in accordance with its evaluation criteria. Notwithstanding the foregoing, BPC reserves the absolute right **not** to accept the highest bid, or any bid, at its sole discretion.
- 1.3 All decisions of BPC regarding bid evaluation, acceptance, or rejection shall be **final, conclusive, and binding**. BPC shall not be obliged to provide justifications or enter into correspondence regarding such decisions.
- 1.4 All bids must be submitted and successfully received by BPC **in the manner specified in the Instructions to Bidders**, on or before the stipulated Bid Submission Deadline. Late submissions will not be considered.

2. DEFINITION OF TERMS

In this Conditions of Sale, the following terms bear the meanings assigned to them below -

"Item(s)" means the property, materials, or goods offered for sale by BPC, as described in the Bill of Quantities.

"Purchase Price" means the total price at which the Item(s) are sold to the Buyer under these Conditions of Sale;

"Buyer" means the successful Bidder, whether a person, company, or entity, to whom the Item(s) are sold.

"BPC" means Berakas Power Company Sdn Bhd, the *Seller*.

3. DISCLAIMER

- 3.1 All Items are sold strictly **"as-is, where-is"**, in their existing condition and location. No guarantees or warranties, whether express or implied, are provided by BPC with respect to the condition, completeness, accuracy of description, merchantability, or fitness for any particular purpose.
- 3.2 Site visits are strongly recommended prior to bid submission to ensure proper assessment. Bidders are deemed to have conducted their own due diligence, including physical inspection and verification of the Items, prior to submitting their bids.
- 3.3 No claims for price adjustment, compensation or cancellation shall be entertained on the basis of incomplete, inaccurate, or insufficient information once a bid has been submitted.
- 3.4 The responsibility to assess the condition, quality, and quantity of the Items rests solely with the Buyer. BPC will not provide technical reports, inspection records, or certificates. If such documents are required, the Buyer shall be solely responsible for obtaining them at their own cost and risk.

4. PURCHASE PRICE

- 4.1 The Purchase Price stated in the Buyer's bid shall be **inclusive of all costs** associated with collection, removal, loading, transport, labour, equipment, personal protective equipment (PPE), and compliance with all applicable safety regulations and procedures of BPC and relevant Government Authorities.
- 4.2 The Purchase Price for each awarded Item shall be **payable in full** within **seven (7) calendar days** from the date of the Letter of Award.
- 4.3 Payment shall be made via wire transfer to the BPC bank account specified in the invoice. No other form of payment will be accepted unless expressly agreed in writing by BPC.

5. ACCEPTANCE OR NON-ACCEPTANCE OF BID

- 5.1 A binding contract of sale is formed only upon BPC's issuance of a Letter of Award to the successful Bidder.
- 5.2 BPC reserves full discretion in accepting or rejecting bids, without obligation to justify its decisions. All such decisions are final.
- 5.3 Any attempt by a Bidder to influence the outcome of the bidding process through bribery, inducement, or other unethical conduct shall result in the immediate disqualification of the Bidder and may lead to legal action in accordance with applicable laws.

6. POSSESSION AND COLLECTION OF THE ITEMS

- 6.1 Title and ownership of the Items shall transfer to the Buyer only upon full and final settlement of the Purchase Price.
- 6.2 No Items shall be released to the Buyer until full payment has been received and cleared in BPC's designated bank account.
- 6.3 Upon confirmation of full payment, the Buyer shall assume all risks and liabilities associated with the Items, including the risk of loss, damage, or deterioration, whether or not the Items have been collected.
- 6.4 The Buyer shall be responsible for arranging, at its own cost, risk, and coordination, the collection and removal of the purchased Items from BPC premises within seven (7) calendar days from the date of payment confirmation.
- 6.5 Failure to collect the Items within the stipulated timeframe may result in:
 - Imposition of storage or handling charges;
 - Disposal of the uncollected Items without further notice; or
 - Forfeiture of payment at BPC's sole discretion, without any obligation for refund or compensation.

7. BUYER'S DEFAULT

- 7.1 In the event the Buyer fails to make full payment within the specified timeframe or otherwise breaches any provision of these Conditions of Sale, the Buyer shall be deemed **in default**.
- 7.2 Upon such default, BPC reserves the right to take any or all of the following actions, at its sole discretion:
 - Cancel the award without any obligation to the defaulting Buyer;
 - Re-offer the Item(s) for sale to another Bidder or by other means;
 - Seek compensation for any losses, costs, or damages resulting from the default, including any shortfall in resale value.

8. GOVERNING LAW & DISPUTE RESOLUTION

- 8.1. These Conditions of Sale shall be governed by and construed in accordance with the laws of Brunei Darussalam.
- 8.2. Any disputes arising from or in connection with these Conditions of Sale shall be subject to the exclusive jurisdiction of the courts of Brunei Darussalam.

 - the collection, removal, and transportation of these items from BPC's storage facility to the Buyer's premises;
 - all labour, equipment, personal protective equipment (PPE), and any safety training costs required for the safe collection and transportation of the items;
 - compliance with all applicable safety rules, regulations, and guidelines imposed by BPC and relevant Government Authorities.
2. The interested Bidders are strongly advised to conduct a site visit and inspection of the items prior to submitting their bids.
3. Once a bid has been submitted, no claims for discrepancies, adjustment, additional costs, or compensation shall be entertained on the basis of lack of information whether incomplete, inaccurate, or insufficient.
